NOTICE OF NONCOMPLIANCE

With Violation-Response/Compliance-Schedule-Approval (CSA) Form

THIS IS AN IMPORTANT NOTICE. FAILURE TO TAKE ADEQUATE ACTION IN RESPONSE TO THIS NOTICE COULD RESULT IN SERIOUS LEGAL CONSEQUENCES. THIS NOTICE IS ISSUED PURSUANT TO M.G.L. c. 21A § 16, 310 CMR 5.00 AND M.G.L. c. 111, §§159-160 AND 310 CMR 22.00.

Dear Mr. Mammolette:

The Massachusetts Department of Environmental Protection (MassDEP) has conducted a sampling location audit following the completion of 2015 Lead and Copper Rule monitoring. MassDEP has determined that one or more lead and copper samples was/were collected from sites not on your public water system's approved Lead and Copper Sampling Plan, constituting a violation of 310 CMR 22.06B(7)(b). The failure to conduct appropriate monitoring indicates that the Georgetown Water Department was not in compliance with one or more laws, regulations, orders, licenses, permits, or approvals enforced by MassDEP. Enclosed is a Compliance-Schedule-Approval (CSA) Form which includes required compliance actions and deadlines.

If you fail to comply with requirements of this Notice of Noncompliance (NON) by the prescribed deadline(s), or if you otherwise fail to remain in compliance in the future with requirements applicable to you, you could be subject to legal action, including, but not limited to, criminal prosecution, court-imposed civil penalties, or civil administrative penalties assessed by MassDEP. A Civil Administrative Penalty may be assessed for every day from now on that you are in noncompliance with the requirements referred to above.

DESCRIPTION OF NONCOMPLIANCE

Failure to collect lead and copper samples according to the approved sampling plan.

DESCRIPTION OF THE APPLICABLE REGULATIONS:

310 CMR 22.03(1) states, in part: "Failure to comply with 310 CMR 22.00 constitutes a violation. For any violation...the Department may set a schedule for compliance within an enforcement document with specific interim measures that the supplier of water must take."

310 CMR 22.03(2) states, in part: "The Department may require a public water system to sample and analyze its water for any parameter at any location and frequency which the Department deems necessary to ascertain the purity of water and fitness of a system to ensure the delivery of a fit and pure water supply to all consumers. The Department may presume that a public water system that has failed to report monitoring results to the Department in accordance with 310 CMR 22.00 has failed to conduct such monitoring..."

310 CMR 22.06B(7)(a) states, in part "All samples must be collected in accordance with the system's Department-approved sampling plan."


310 CMR 22.16 states, in part: "(1) Each supplier of water for a public water system shall give notice for all violations...and for other situations, as listed in 310 CMR 22.16: Table 1 or specified by the Department in writing..."

ACTIONS TO TAKE AND DEADLINES:

- (1) selecting and implementing Option 1; or
- (2) selecting Option 2 and obtaining MassDEP's approval of your corrective action plan and schedule, then implementing the plan, as approved


