Marlene reports that the FY23 budget remains on point with projections. Construction has been higher than usual due to the 51 West Main Street and 66 Parish Road developments. Marlene alerted the board that pipes, valves, and chemical prices are still increasing. Due to a chemical plant fire and possible supply issues the department has purchased extra bulk chemical causing an abnormal usage cost Also in efforts to keep construction prices down using government funding for gate repair, two gates were purchased in advance of infrastructure repair.
